## **Waiver**

As a participant in the NorthWestKayakAnglers.com Salmon SlayRide Derby, October 11<sup>th</sup>, 2014 I hereby agree to release and discharge the organizers, sponsors, volunteers (organizers), and other participants on behalf of myself, my spouse, my children, my heirs, assigns, personal representative and estate as follows:

1. I acknowledge that kayak fishing entails known and unanticipated risks which could result in physical or emotional injury, paralysis, death or damage to myself, to property, or to third parties. I understand that such risks simply cannot be eliminated without jeopardizing the essential qualities of the activity.

The risks include, among other things: boat/kayak capsize, tidal conditions and currents, travel to remote areas, collision with objects or other watercraft, prolonged exposure to cold water, hypothermia, accidental drowning, mental anguish or trauma, illness in remote areas, exposure to sun, strong wind, cold, storms, large waves, eddies and whirlpools, lightning, aggressive and/or poisonous marine life, wrist, arm, shoulder and/or back injuries, slips and falls, and rapidly changing adverse weather and water conditions.

Furthermore, the event organizers have difficult jobs to perform. They seek safety, but they are not infallible. They might be ignorant of a participant's fitness or abilities. They might misjudge the weather, the elements, or the terrain. They may give inadequate warnings or instructions, and the equipment being used might malfunction.

2. I expressly agree and promise to accept and assume all of the risks existing in this activity. My participation in this activity is purely voluntary, and I elect to participate in spite of the risks.

3. I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless the organizers, sponsors, volunteers and other participants of this event from any and all claims, demands, or causes of action, which are in any way connected with my participation in this activity, including any such claims which allege negligent acts or omission of the organizers.

4. I hereby authorize and give my full consent to
